Public Information: Paulina Salgado: TriMet

Paulina presented the proposed Park Ave garage project by TriMet. TriMet is proposing to add two additional levels to the existing parking garage. The garage was originally designed for five levels but only three were constructed when the Park Ave station was built. Additional parking while not required currently is expected to be needed by the time of its completion currently slated to be done in 2026. Some concerns were expressed and an interest in more information on the scope and schedule of the project. Paulina expects to be back periodically at the OGCC General meeting to provide more information and project updates.
